

HOSPITAL OUTPATIENT SETTING Q2 2020 PuraPlyTM AM

Medicare Product and Related Procedure Payment for Wound size less than 100 sq cm

- Effective October 1, 2018 PuraPly and PuraPly AM have pass-through status until 9/30/2020 and therefore will be separately reimbursed. Pass-through status for PuraPly and PuraPly AM will expire on 9/30/2020.
- The reimbursement for PuraPly and PuraPly AM (product code) is NOT subject to a copayment amount in the Hospital Outpatient Department while on pass-through. The copayment is applied to the application code.
- PuraPly and PuraPly AM will be reimbursed ASP + 6% minus the CMS offset rate of \$759.52 for 2020.
